Charitable organization of Interecocentre (further – Organization), non-governmental organization (NGO) is the voluntarily association of citizens, created with the purpose of provision and implementation of charitable assistance to citizens and organizations and is operated on the basis of principles of equality of rights of his members, self-government, legality and publicity, in according to Constitution of Ukraine, Law of Ukraine "On the association of citizens" and Law of Ukraine, "On Charity and Charitable Organizations".

1. Name, location, status and legal form of Organization

- 1. 1. Organization is the voluntarily public association created by citizens on a voluntary basis and on the basis of unity of their interests.
- 1. 2. Organization is an independent legal entity from the moment of its state registration, has the separated property, conducts independent balance, has Ukrainian hryvna and other currency accounts in banks, round seal with the complete and brief name incorporated in according to legislation. Also Organization has stamps and attribute and symbolism the standards of which have to be approved by the Board and be registered in according to legislation.
- 1.3. Organization for achieving its goals has a right on behalf of its own to conclude agreements, contracts, acquire property and personal rights and to represent itself in a court and arbitration court, to have other rights, that foreseen the current legislation of Ukraine.

- 1.6 The full name of Organization is the Charitable organization "Interecocentre", brief name : "Interecocentre",
- 1.7 Activities of organization spreads on territory of two or more administrative- territorial units.
- 1.8 A legal form is a charitable organization.

II. Object, aims, objectives and main forms of activities

2.1. Object of charitable activity

Beneficiaries of charitable provision cab be natural and legal persons needed in it.

2.2. Aims of Organization

The main objectives of Organization are:

- donation and implementation of grants to legal and natural persons in directions of environmental protection;
- improvement of the environment by implementation of projects, facilitation of public awareness, information-publication activities;
- conducting scientific research, expertise etc.;
- facilitation of development of science, education, protected areas fund;
- revival of spirituality of people;
- conducting actions of mercy and charity;
- satisfaction and defense of legal interests of members of the Organization

The purpose of Organization is non profit.

2.3. Objectives of Organization

For achieving the main aims the Organization has the following objectives:

• takes part in organization of preparation and implementation of international contracts, agreements with governmental and nongovernmental organizations, Ukrainian and foreign institutions, legal and natural persons in direction of ecology, protection of environment and natural resources and improvement of socio-economic state;

- facilitation of practical implementation of the national, regional, local and international programs which are directed on the improvement of the state of environment and environment protection.
- facilitation of development of protected area fund of and nature conservation;
- search of foreign investors and realization projects and services to be effective for Ukraine;
- organization and conducting of symposiums, conferences, seminars;
- acquisition, lease of vehicles of transports, devices, equipment, property, real estate and other objects.
- assistance development of science and education, realization of the scientifically educational programs, presentation of assistance to teachers, scientists, students, students;
